There have been two topics discussed over the last couple of months that I think needs to be talked about and taken care of soon so we can get to other things. I hope this article gets you attention and fills you in on what's going on with my opinion on the topics.

There has been talk about the possible of raise dues since last year. The current dues I think are to low considering we have a clubhouse now that we hope to keep past July 2011. Dues are one way to make money to be able to keep our home. With the membership right now and our current dues we have enough money to just cover one months rent. I will be the first to say that I do not like the idea of raise dues however if it helps us to be able to keep a clubhouse I say go for it. The current talk has been to raise dues to \$10.00 a month, which would be \$120.00 a year. However it was also talked about if you pay a year in advance we would make it \$100.00, which would save you \$20.00. I think this is a fair and reasonable price and the only thing I would add would be a family package and new member package. I would make the family package \$15.00 a month or \$150.00 if you pay a year in

advance. For the new member package I would make it \$5.00 a month for a single member and \$7.00 a month for a family for the first year, with the year in advance being \$50.00 and \$74.00.

The other topic I would like to give my opinion on is the idea of switching the club meeting to the second Tuesday and the work session to the fourth. I will not go into the reason why this came up, but I will say it is a good idea considering we do you have a meeting in November and December because meetings far close to major holidays. With this change we could have meetings and not worry about members being busy with the holidays. I think having meeting in those months would help because we have three major club events happen during those month, which are Railfair, The Christmas Open House, and the election in January. The meeting can help to make sure everybody is on the same page and are ready for the events.

I hope I got your attention with this article and I hope this helps with getting these things done soon.
